

# Our Programs

### Long-Term Care

Our 150-bed Long-Term Care Home is designed for people who need access to 24 -hour nursing care, supervision or higher levels of personal care than can be provided in the community.

It features five residential home areas with large, light-filled resident rooms, an activity room, living room and dining room.

Common areas include Jeanne Mance Hall, the Café, the Gathering Space and enclosed courtyards. We provide 24-hour nursing, access to medical services, wholesome food and a variety of therapy, recreation, spiritual and leisure programs to ensure that residents enjoy the best possible quality of life.

### Complex Continuing Care

The 50-bed Complex Continuing Care program serves a variety of patients who require a multi-disciplinary team of healthcare professionals including nursing, physiotherapy, occupational therapy, recreational therapy, spiritual care, dietary and social work, to manage their care.

Patients are generally medically-stable but require daily nursing care and assistance beyond what can be provided in the community or long-term care setting.

### **Restorative Care**

The goal of the Restorative Care Program is to strengthen and condition the patient to a level of independence that will allow them to be discharged to the community (home, retirement residence) preventing admission to Long-Term Care.

Patients admitted to the program are medically-stable, but have experienced a decline in their independent function due to progressive debilitation or physical deconditioning.

They receive physiotherapy and occupational therapy, and also benefit from social activities and shared dining. The expected length of stay is 90 days after which they are discharged to the community with supports in place.


