Meet Our Patients - Phyllis' Story



Phyllis Leroux's first patient experience at St. Joseph's Continuing Care Centre was in November 2011 when she was admitted to our Assess and Restore (A&R) Unit operated out of the Cornwall Community Hospital (CCH) Second Street Site. During her fourteen-month stay in the A&R program Phyllis participated in a range of activation programs, organized recreational activities for her co-patients and undertook advocacy efforts engaging our MPP in dialogue about various health care issues in our community. She felt a sense of security and belonging but there was uncertainty looming with the planned closure of the A&R Unit. The uncertainty was over when in January 2013 Phyllis was admitted to St. Joseph's Continuing Care Centre Long-Term Care (LTC) program. Her first reaction when entering the facility on York Street was "I'm home." After being in and out of hospital for the past several years and having to give up her home in the community it was time for new roots. It wasn't long before Phyllis was once again actively involved in all aspects of resident life at St. Joseph's and in the community; organizing activities for co-residents, chairing the Residents' Council, attending community events, etc. Phyllis felt very supported by the team here at St. Joseph's and all her care needs were met. Life was good. Tragically, in December 2014 during her regular trip to the Dialysis Unit at CCH, Phyllis suffered a stroke and life changed again. After receiving excellent acute care at CCH, Phyllis came back to St. Joseph's in January 2015 as a patient in our Complex Continuing Care (CCC) Restorative Care unit. Working with the team in CCC goals were established for her rehabilitation including to return to using her power chair, to overcome her fear of falling, and to regain her independence and return to the activities she previously enjoyed. The stroke had affected her mobility, range of motion, speech, vision and her overall level of independence. The collaborative efforts of Phyllis and the team in CCC allowed her to achieve all of her rehab goals and in May 2015 Phyllis returned to the LTC program and all the activities of daily living she loves. Today, Phyllis says she feels happy, relaxed, secure and independent and has a sense of purpose. "God brought me to St. Joseph's for a reason and brought me back here for a reason. I am grateful for the team here at St. Joseph's and the strength, support and prayers from my friends and my church."
