UPDATES TO VISITATION AND ABSENCES: LONG-TERM CARE

Effective December 30th, 2021



INDOOR VISITATION

Up to two (2) Designated Caregivers per resident at one time.

OVERNIGHT ABSENCES

Overnight absences for social purposes are suspended, regardless of vaccination status.

GENERAL VISITORS

All General Visitation is suspended at this time.

GATHERINGS/RECREATION

Cohorts of residents for high-risk activities (singing, dancing, etc.) and large group social activities are discouraged.

DESIGNATED CAREGIVERS

To gain entry to the Centre, Designated Caregivers must show proof of their first dose as of December 20th, 2021. **All Designated Caregivers must be FULLY vaccinated by February 21, 2022, and show proof of all required doses.**

Caregivers designated after December 14th are required to be fully vaccinated to gain entry to the Centre.

All fully vaccinated Designated Caregivers must be Rapid Antigen Tested at minimum 2 times per week, in addition to existing testing requirements for those not fully vaccinated. **Please remember:** Rapid Antigen Testing Clinic is only open 6:00 am - 5:45 pm, daily. Tests are only valid for 48 hours.
